A medical issue arose that forced her to stop working, apply for Disability Benefits, and even give up her comfortable home. The deep appreciation she's held for our community was shaken as she attempted to navigate the process of rebuilding her life. Susan shared, "This town looks different to me now. Potentially being homeless is scary."

### Not Alone...

Unfortunately, Susan's story is not unique. In our region, nearly half of all households are living paycheck to paycheck, one emergency away from financial ruin.
